6. (a) Summary of what the rule says and of any proposed amendments including whether the rule implements a state statute for the first time:

The Physical Therapy Governing Board (Board) intends to readopt with amendment Phy 200, Practice and Procedures Rules, to incorporate by reference Plc 200 as adopted by the Executive Director of the Office of Professional Licensure and Certification (OPLC) to replace the incorporation by reference of Ahp 200 of the Office of Allied Health Professionals. The Office of Allied Health Professionals was eliminated pursuant to 2023, 79:277, effective September 1, 2023. OPLC was granted rulemaking authority in RSA 310:6, II to adopt organizational and procedural rules necessary to administer the boards, pursuant to 2023, 235:8, effective July 15, 2023. The Board proposes to adopt rules to incorporate the Plc 200 rules under the authority of RSA 541-A:16, I(b)-(d) to include investigation of misconduct complaints and the conduct of adjudicative and non-adjudicative proceedings. The Board further proposes to change chapter 200 heading to comply with the standardized chapters for professional licensing boards as stated in the New Hampshire Drafting and Procedural Manual.

The rule affects the general public, licensed physical therapists, and individuals seeing licensure as a physical therapist in New Hampshire.
