VII. Rules Review and Other Legislative Topics

A. Legislation Updates - Board Counsel

HB 1676 - establishing a sunset commission to evaluate various occupational boards and commissions, and sunsetting various boards and commissions - Opposed - referred to interim study

HB 1240 - relative to eating disorders as a qualifying condition for the therapeutic cannabis program - to be monitored - ought to pass

HB 1190 - relative to adopting the interstate social work licensure compact - Supports – ITL (inexpedient to legislate)

HB 1272 - relative to occupational license reciprocity - to be monitored - ITL

HB 1278 - relative to qualifying medical conditions for purposes of therapeutic cannabis - to be monitored - ought to pass

HB 1112 - relative to establishing a continuing education requirement regarding human trafficking for individuals licensed by the office of professional licensure and certification - to be monitored - ITL

SB 533 physical quorum - ITL

HB 1521 - requiring agencies to respond to issues raised during rulemaking – Hearing scheduled

Plc 313.23 <u>Substantially Similar Requirements for the Profession</u> <u>Regulated by the Board of Licensed Dietitians.</u>

For purposes of obtaining a dietitian license by endorsement, as regulated by the board of licensed dietitians, the current requirements of the licensing jurisdiction shall be as follows:

(a) Pass the registered dietitian (RD) examination administered by the Commission on Dietetic Registration.
