### **III. Hearings/Public Appearances**

- A. Molly Rossignol, Director of NH Professional Health Program (PHP) appeared before the Board to answer questions regarding what participants are actually being “monitored”. If someone is in treatment, they are not monitored based on they are actively participating in the program. Some participants enter programs voluntarily, whereas some just reach out because of “burn out”, which in these cases they are “unmonitored” although followed up upon. The status of “completed” participant is they either “opt out” or make the decision not to participate in PHP program. Ms. Rossignol stated that NHPHP has an increase of 50% - 75% in calls to the program in just over the last year.
