- II. Legislative Hearing on HB 322 at 9:00am on Wednesday March 6th 2024
 - A. Director Lindsey Courtney arrived to provide context from an OPLC perspective and ask for a collaborative approach to testifying and inform the Board.

B. Public Appearance

- 1. Malcom Hauthaway, President Physician's Assistant Society ~ 10:00 am
 - a. Supervision agreements barrier for PA practice. Why should a Physician be responsible for the care a PA provides if they are not performing the care. SB 228 passed and they thought the burden has passed however, when the Physician leaves a practice, the PA's have been losing their jobs. There are also some insurance implications causing adminstrative and financial burdens for offices.
 - b. With HB 1222 they see why it's here and that is why they back it.It gives PA's parody with Nurse Practitioners.
 - c. HB 1222 removes supervision and instead uses the word collaboration.
 - d. Perhaps PA's might work under agreement for a certain number of hours?
 - e. This is a workforce issue in that it seems to become easier to employ RN's over PA's as they do not require all of the paperwork and insurance requirements.
 - f. When it comes to the patient safety aspect, it's become attractive to legislators, it removes the red tape barrier that is impacting healthcare employment without sacrificing patient safety.
 - g. There is some worry about increasing scope of practice if this continues as it is, as all professions seem to be heading that way. DF brought up that PA's have been around for 50 years and the insitutional training would be a barrier against that.

h. The ask is that the Board add their support to this legislation that they are going to testify for later today 3/6/24.

Upon a motion by JB, with a second by NG the Board voted to state that it would support legislation that accomplishes the goals of HB 1222, provided that an hours practice requirement was added in lieu of the collaboration agreements.

- 2. Molly Rossignol, Director NHPHP Informational
 - a. Proposal of rules for approved programs / Plc 500's.
 - b. PHP has gone through them with a fine tooth comb, concerns have to do with confidentiality. If it isn't a confidential program, people would be less likely to contact NHPHP.
 - c. Looking at application questions that may ask questions that are intrustive or may violate ADA.
 - d. Med 407.02 implies the applicant has to "out" themselves if they are part of a PHP.
 - e. It could also dictate what NHPHP has to report to Boards. In the opinion of Dr. Rossignol, this is more information than is needed.
