

**NH BOARD MENTAL HEALTH PRACTICE
PUBLIC EMERGENCY
MEETING MINUTES
February 9, 2024
Via Zoom**

CALL TO ORDER

An emergency meeting was called to order at 1:02 PM

The following board members were present: Deborah Robinson (DR), Amy Alletzhauser (AA), Rebecca Bemis (RB), Kristin Grasso (KG), Courtney Porter (CP) and Lara Gruner-Orf (LGO)

The following board members were absent: Samuel Rosario (SR), Christina Gribben (CG)

The following non board member(s) were present: Jeanne Webber (JW), Administrator; Shane Goulet, Esq (SG), Board Hearing Examiner; Elizabeth Eaton, Esq., (EE), Board Counsel

RSA 91-A:3, II (i) *Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.*

NON PUBLIC

The following applies to all Non-Public Sessions.

All Non-Public Sessions are recorded as follows for the purpose of board business and noting that such a non-public session is authorized by RSA 91-A:3, II (c), RSA 91-A:3, II (e), RSA 91-A:5, IV, and the Board's executive and deliberative privileges. However, forty-eight hours after the mailing of any order, its respective vote shall automatically become public in accordance with RSA 330-A:29.

Upon motion of KG seconded by DR, the Board voted to commence the non-public session at 1:04 p.m. and ended at 1:14 p.m.

Motion to come out of non-public was made by KG, and seconded by DR, by unanimous roll call vote.

Upon the motion of DR and the second of LGO, the Board voted to keep minutes of the non-public session confidential from public disclosure. Each member recorded his or her vote on the motion, which passed by unanimous vote.

HEARING:

The Matter of Colleen Ann Murphy, Unlicensed – Hearing commenced at 1:02 p.m. Motion made by DR and seconded by RB to issue a Notice of Emergency Hearing due to evidence that Ms. Murphy poses an imminent threat to the public’s health, safety and welfare. Motion passed via unanimous roll call vote.
