TPA-certified licensees:

50 hours per year

20 hours of Class I minimum

8 of which may be alternative

30 Hours Class I

Glaucoma-certified licensees:

50 hours per year

20 hours of Class I minimum

8 of which may be alternative

minimum 7 hours of which must be glaucoma specific

30 Hours Class II

3 hours of glaucoma specific education may be Class II

Non-TPA-certified licensees

15 hours per year Class I

2 hours of which may be alternative
