VOLUNTARY SURRENDER OF LICENSE


Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Barbering, Cosmetology & Esthetics Board ("Board") concerning the revocation of my license to practice as a cosmetologist in the Commonwealth of Pennsylvania, I, Lan Tien Vu, hereby voluntarily surrender my New Hampshire license (#10650) effective on the date that the Board accepts this offer of voluntary surrender.

By voluntarily surrendering my license to practice as a cosmetologist, I understand that:

1. I relinquish all rights and privileges to practice as a cosmetologist in the State of New Hampshire effective upon the Board's acceptance of this voluntary surrender.
2. I admit that this license surrender has occurred in settlement of pending disciplinary charges.
3. I am not relinquishing my Manicurist License and will continue to operate my studio practicing manicuring and pedicuring, which includes providing acrylics and other nail applications.
4. I admit to no violations of RSA 313-A:22, II but recognize that the fact of my voluntary surrender will be distributed by the Board as a disciplinary action.

5. I plan to again seek licensure for cosmetology in the State of New Hampshire. I understand that at that time I must meet and shall bear the burden of proving compliance with all of the standards and prerequisites then required by the Board for new applicants, including professional character requirements.
6. I understand that the pending disciplinary allegations shall be resolved in any future licensure application I may submit in New Hampshire. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations.
7. I understand that if the Board chooses to accept my surrender of license, this document shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making specific finding of professional misconduct. I recognize that the fact of my voluntary surrender will be distributed by the Board as a disciplinary action. I further understand that this document shall become a permanent part of my file, and will be maintained by the Board as a public document.
8. I voluntarily submit this surrender of license to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
