**RESOLUTION AGREEMENT**

5. The narrative prepared by Ms. Stockman, and the Report of Investigation, dated July 25, 2014 shall be removed from the Respondent's files and maintained separately by the Director; and
6. Respondent David Holden shall execute a release for the benefit of the State and Ms. Beulah Stockman in her individual and official capacity, as to all claims asserted or assertable in this matter.


