VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending before the New Hampshire Board of Barbering, Cosmetology and Esthetics ("Board") concerning violations of statutes and Board rules related to the operation of tanning facilities, The Lodges at West Edge ("The Lodges"), hereby voluntarily surrenders its New Hampshire Tanning Facility Registration number 546 effective on the date that the Board accepts this offer of voluntary surrender.

By voluntarily surrendering its license, The Lodges understands that:


1. All rights and privileges to operate a tanning facility in the State of New Hampshire are relinquished effective upon the Board's acceptance of this voluntary surrender.
2. The Lodges acknowledges that this license surrender has occurred in settlement of pending disciplinary charges.
3. The Lodges admits to no violations of RSA 313-A:22, but recognizes that the fact that this voluntary surrender will be distributed by the Board as a disciplinary action.

4. Should The Lodges again seek licensure in the State of New Hampshire, it must meet and shall bear the burden of proving compliance with all of the standards and prerequisites then required by the Board for new applicants.
5. The Lodges understands that the pending disciplinary allegations shall be resolved in any future licensure application that The Lodges may submit in New Hampshire. The Lodges hereby specifically waives any statute of limitations or laches defense, which might then be available as to these misconduct allegations.
6. The Lodges understands that if the Board chooses to accept this voluntary surrender, this document shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making specific finding of professional misconduct. The Lodges understands that this document shall become a permanent part of The Lodges file, and will be maintained by the Board as a public document.
7. This surrender of license is voluntarily submitted to the Board with the understanding that no promises or representations have been made other than those terms and conditions expressly stated herein.


