SETTLEMENT AGREEMENT

In order to avoid the delay and expense of further proceedings and to promote the best interests of the public, the New Hampshire Electricians' Board (hereinafter "Board") and Kevin P. Delaney (hereinafter "Respondent"), DEI Systems LLC Partner licensed by the Board, do hereby stipulate and agree to resolve certain allegations of professional misconduct now pending before the Board according to the following terms and conditions:

1. Pursuant to RSA 319-C:6-a, 319-C:12, 319-C:12-b, and the Board of Electrician's Practice and Procedural Rules the Board has jurisdiction to investigate and adjudicate allegations of professional misconduct committed by electricians. Pursuant to RSA 319-C:12 and Elec 207.07 the Board may, at any time, dispose of such allegations by settlement and without commencing a disciplinary hearing.
2. The Board first granted Respondent a license to practice electrical installations in the State of New Hampshire as a Master on September 7, 2006. Respondent currently holds master license number 11872M. DEI Systems LLC. currently holds corporate license number 0445C issued on December 19, 2017.
3. In response to information received from Manchester Code Enforcement Officer Jim Tierney regarding an inspection on October 23, 2017. Inspector Denis Laurendeau, performed an investigation regarding electrical installations performed by DEI Electric at Lot015-004B Kidder-Canal Street, 805 Canal Street and 89 Dow Street, Manchester, NH. The investigation conducted by, State Electrical Inspector Denis Laurendeau disclosed information from various sources pertaining to, Respondent's violations of the provisions of the Respondents June 6, 2017 settlement agreement with the Board, job reporting requirements, RSA 319-C and the Board of Electrician's Practice and Procedural Rules.

4. The investigation revealed and Respondent freely admits to the following facts:

The Respondent failed to report electrical installations performed by DEI Electric at Lot015-004B Kidder-Canal Street, 805 Canal Street and 89 Dow Street, Manchester, NH. This is in violation of the provisions of his settlement agreement dated June 6, 2017 with the Board, RSA 319-C and the Board of Electrician's Practice and Procedural Rules. The Board finds that Respondent committed the acts as described above and concludes that, by engaging in such conduct, Respondent violated section 8 of his settlement agreement dated June 6, 2017, RSA 319-C:12(II)(c), 319-C:15(d) and Elec 405.01(a)(1)(5).

5. Respondent acknowledges that this conduct constitutes grounds for the Board to impose disciplinary sanctions, as stated in section 8 of his settlement agreement dated June 6, 2017, Elec 405.03(h), against Respondent's license to practice as an electrician in the State of New Hampshire and represents that he has taken steps to avoid any repetition of such conduct.

6. There is no current record of a similar violation on file at the Board's office.

7. Respondent is willing to accept that this is a violation of section 8 of his settlement agreement dated June 6, 2017. As described in section 9 of the settlement agreement dated June 6, 2017 and Elec 405.03(h), this shall be considered as a disciplinary action until January 6, 2025, as described in Elec 405.03(i).

8. Respondent consents to the Board imposing the following discipline, pursuant to RSA 319-C:12 and Elec 405.02:

A. Respondent is **reprimanded**.

B. Respondent's license is **suspended** until June 1, 2018 the balance of the deferment in the settlement agreement dated June 6, 2017 and may petition the board to reinstate his masters' license after that date. The Respondent shall deliver to the Boards' office his masters license within 10 days of the acceptance of this agreement by the Board. If the Respondent fails to comply within the 10 days the Respondents masters' license shall be suspended for the original deferment of 12 months.

The corporation DEI Systems LLC license number 0445C shall report for the original deferment of 12 months to the Board on a monthly basis in a written report of the location of any current or projected jobs in NH. The reports shall include jobs (completed or projected) from the first day of the month to the first day of the following month. The report, supplied by the Board shall be received in the Board's office by the first day of the month, with the first report due February 1, 2018 and the last report due on January 1, 2019. A report shall be filed each month even if no work is performed in NH. The reports shall include jobs (completed or projected) from the first day of the month to the first day of the following month. The report, supplied by the Board shall be received in the Board's office by the first day of the month.

C. The Board may consider Respondent's compliance with the terms and conditions herein in any subsequent proceeding before the Board regarding Respondent's license.

9. Respondent's breach of any terms or conditions of this *Settlement Agreement* shall constitute unprofessional conduct pursuant to RSA 319-C:12, and a separate and sufficient basis for further disciplinary action by the Board.

10. Except as provided herein, this *Settlement Agreement* shall bar the commencement of further disciplinary action by the Board based upon the misconduct described above. However, the Board may consider this misconduct as evidence of a pattern of conduct in the event that similar misconduct is proven against Respondent in the future. Additionally, the Board may consider the fact that discipline was imposed by this Agreement as a factor in determining appropriate discipline should any further misconduct be proven against Respondent in the future.


11. This *Settlement Agreement* shall become a permanent part of Respondent's file, which is maintained by the Board as a public document.

12. Respondent voluntarily enters into and signs this *Settlement Agreement* and states that no promises or representations have been made to him other than those terms and conditions expressly stated herein.
13. The Board agrees that in return for Respondent executing this *Settlement Agreement*, the Board will not proceed with the formal adjudicatory process based upon the facts described herein.
14. Respondent understands that his action in entering into this *Settlement Agreement* is a final act and not subject to reconsideration or judicial review or appeal.
15. Respondent has had the opportunity to seek and obtain the advice of an attorney of his choosing in connection with his decision to enter into this *Settlement Agreement*.
16. Respondent understands that the Board must review and accept the terms of this *Settlement Agreement*. If the Board rejects any portion, the entire *Settlement Agreement* shall be null and void. Respondent specifically waives any claims that any disclosures made to the Board during its review of this agreement have prejudiced his right to a fair and impartial hearing in the future if this *Settlement Agreement* is not accepted by the Board.
17. Respondent is not under the influence of any drugs or alcohol at the time he signs this *Settlement Agreement*.
18. Respondent certifies that he has read this *Settlement Agreement*. Respondent understands that he has the right to a formal adjudicatory hearing concerning this matter and that at said hearing he would possess the right to confront and cross-examine witnesses, to call witnesses, to present evidence, to testify on his own behalf, to contest the allegations, to present oral argument, and to appeal to the Building Code Review Board, pursuant to RSA 155-A:11-a. Further, Respondent fully understands the nature, qualities and dimensions of these rights. Respondent understands that by signing this *Settlement Agreement*, he waives these rights as they pertain to the misconduct described herein.

19. This agreement shall take effect as an *Order of the Board* on the date it is signed by an authorized representative of the Board.


