**PRELIMINARY AGREEMENT NOT TO PRACTICE**

The New Hampshire Board of Registration of Medical Technicians ("Board") granted Sophia Zeigfnger ("Respondent") a State of New Hampshire <sup>Registration</sup> ~~license~~ to practice as a registered medical technician on September 6, 2017. Respondent holds license number 001707.

The Board received two separate complaints from two different facilities, the most recent one being on April 19, 2019, while working as a CT Technologist at Concord Hospital in Concord, New Hampshire.

Respondent enters into a Preliminary Agreement with the Board as follows:

1. Recognizing that professional misconduct allegations are now pending against me before the Board, I, Sophia Zeigfnger, hereby voluntarily agree not to practice as a medical technician until further order of the Board.

2. I admit to no violations of RSA 328-I:10 or any other laws, statutes or regulations.

3. Understanding that this Preliminary Agreement and the restrictions herein shall remain until further order of the Board, I hereby specifically waive any statute of limitations or laches defense, which might then be available, including, but not limited to, those based on RSA 332-G:8 and 9.

4. I understand that I may request a hearing at any time, and a hearing on this matter will be scheduled for the next available hearing date.

5. In the event that I apply for the renewal of my <sup>Registration</sup> ~~license~~ while this agreement is in effect, I voluntarily agree to waive any statutory or administrative time deadlines regarding the Board's final action on such <sup>Registration</sup> ~~license~~ renewal application. I understand that by waiving

such deadlines, the Board's final action on any such <sup>Registration</sup> license renewal application will be automatically deferred until after the disposition of this Board matter and that my <sup>Registration</sup> license will not expire while this Preliminary Agreement is in effect.

6. I voluntarily enter into this Preliminary Agreement with the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.

7. I further understand that this document shall become a permanent part of my file, and will be maintained by the Board as a public document.

8. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this Preliminary Agreement.

9. I am of sound mind and not under the influence of any substance that would impair my judgment at the time I sign this Preliminary Agreement.




