BOARD ORDER

The New Hampshire Board of Registration of Medical Technicians (“Board”) first granted a registration to practice under the rules of the Board to Cheri Nicholson, Medical Technician (“Ms. Nicholson”) on June 18, 2019. Ms. Nicholson holds registration number 002892.

On November 7, 2019 the Board sent a Notice of Hearing to Ms. Nicholson via registered mail in accordance with RSA 328-I:11, II. The Notice of Hearing ordered Ms. Nicholson to appear before the Board on January 9, 2020 at 8:30 am. Ms. Nicholson was scheduled to be the second hearing of the day. The hearing was scheduled to be held at the Philbrook Building, 121 South Fruit Street Concord NH. Ms. Nicholson failed to appear before the Board on January 9, 2020.

THEREFORE, IT IS ORDERED that Ms. Nicholson’s registration, #002892, is suspended pursuant to RSA 328-I:11, which states, in part:

If, when a notice of hearing is mailed to a registrant at the address shown in the records of the board, such a registrant fails to attend such hearing, then the board may suspend his or her registration without a hearing pending his or her attendance at such hearing.

IT IS FURTHER ORDERED, the suspension shall remain in effect until Ms. Nicholson appears before the Board to address the allegations set forth in the Notice of Hearing.

IT IS FURTHER ORDERED that Ms. Nicholson shall, within 5 days of the issuance of this notice, not including Sundays and holidays, deliver to the Board her certificate of registration. If surrendered by mail, the certificate of registration shall be sent by registered or certified mail, postmarked no later than 3 days, not including Sundays and holidays, following this notice of suspension. Failure to return a certificate of registration which has been revoked or suspended within the prescribed time constitutes a misdemeanor pursuant to RSA 328-I:9, II.

IT IS FURTHER ORDERED this Order shall become a permanent part of Ms. Nicholson's file, which is maintained by the Board as a public document. This Order shall also be provided to the Department of Health and Human Services and the Department of Safety in accordance with RSA 328-I:10, XI.

IT IS FURTHER ORDERED this Order shall take effect as a final Order of the Board on the date it is signed by an authorized representative of the Board.
