<p>Jeffrey Audet Disciplinary Hearing</p>	<p>Hearing commenced at 9:35AM when Board President Robert Stout read an outline of the allegations, that Jeff Audet violated (703.03(a); 703.03(b); 805.01(b); 803.01 (a), and how the hearing would be conducted by the board. Representing the board was Administrator Michael Bullek who presented information that Jeff Audet sent store personnel to another pharmacy to obtain a controlled substance to fill a prescription, and failed to report the loss of a controlled substance within the requirements of board rules. Inspector James "Jay" Queenan testified to support the information provided by Administrator Bullek. The board heard testimony from Jeff Audet that he acted appropriately in the care of a patient, that there is no rule or law that an individual sent to another pharmacy is required to be registered with the board, and that the corporate office informed him it had taken care of the reporting requirements.
