- * Saf-Mec 900 Board does not need this section. RSA 153:38 V. states "The board may enter into reciprocity agreements which shall permit the licensing of fuel gas fitters and plumbers from states which have a mutual mechanical licensing reciprocity agreement with this state, for all mechanical license listed in paragraph l(a) provided the board determines that the requirements for licensure in that state are equivalent to, or greater than, those established by the subdivision". The Board already has rules for applicants coming from other states in Mec-300.
- **7. Public Comments-** Les Houston was looking for clarification on code changes and educational providers. M. Prindiville informed Mr. Houston that there is a 6 Month grace period for schools and providers. July 2023 will be when new code will be incorporated into the education as they are halfway through the year with the 2015 codes and will test on those.
