 - A. Legislative update OPLC Board Counsel

1) SB 533 - Physical Quorum

2) HB 369 - Publish meeting timelines

3) HB 1676 - Sunset Bill - Hearing is scheduled for 1/25/24 at 1:30 pm - Board members determine that they would like to compose a letter to be presented at the hearing.

Motion:

Upon a vote by SK and seconded by SR to designate Scott Roy to compose and sign the letter regarding HB 1676 on the behalf of the Board. Motion passed unanimously.
