After reviewing all the documentary evidence, in non-public session, drawing all reasonable inferences therefrom, and taking into account the presentation and demeanor of all the witnesses, the Board finds that Hearing Counsel has met her burden of proof that the Licensee has committed professional misconduct and voted to impose discipline as contained in the order published on the Board's website.

Hearing commenced at 11:42am. Hearings Officer Nikolas Frye asked Mr. Zapata if he had a chance to review the submitted exhibits from Hearing Counsel. Mr. Zapata said that he had not recived a copy of the exhibets prior to the hearing. At 11:49am the Board went into a non-meeting to confer with Board Counsel on how they should proceed. The hearing resumed at 11:55am. Hearings Officer Frye asked Mr. Zapata if he felt comfortable still proceeding with the Hearing today, or would he like to reschedule. Mr. Zapata said he would like to continue. Hearings Officer Frye allowed 10 minutes for Mr. Zapata to review the exhibits before continuing. Attorney Marissa Schuetz called Inspector Sandra Hodgdon as a witness who gave testimony regarding an inspection that took place on April 7, 2022, where violations were found. Mr. Zapata gave testimony explaining that since the inspection he had made inprovements to sanitation practices which included spacing out appointments to allow staff to clean inbetween clients and staff are required to take photos of their stations before leaving for the day. Hearing closed at 12:47am. After reviewing all the documentary evidence, in non-public session, drawing all reasonable inferences therefrom, and taking into account the presentation and demeanor of all the witnesses, the Board finds that Hearing Counsel has met her burden of proof that the Licensee has committed professional misconduct and voted to impose discipline as contained in the order published on the Board's website.
