Dear Sharon M. Silvia Sally A. Yonker, Virginia C. Filippone :

On 8/1/2023, the New Hampshire Board of Barbering, Cosmetology, and Esthetics ("Board") reviewed an inspection report issued to you and/or your business dated 6/16/2023. The inspection report reflects 450 points assessed during this inspection. In accordance with RSA 313-A and administrative rule Bar 404 the Board shall assess fines based on the number of points a licensee has accumulated during the inspection.

The Board has determined, in accordance with RSA 313-A and Bar 400, the total number of points assessed during the 6/16/2023 inspection totals: 450 points. The Board has further assessed a fine in the amount of \$450.

You have three options upon receipt of this notice:

- 1) Pay the fine immediately, payable to "Treasurer, State of NH" no later than within 20 days of receipt of this letter.
- 2) Request, in writing, a pre-hearing.
- 3) Request, in writing, a hearing in accordance with Bar 404.07. The Board will thereafter schedule a hearing on the matter.

**If you choose to 1) Pay the fine immediately, payable to "Treasurer, State of NH" no later than within 20 days of receipt of this letter: Please sign and mail in attached settlement agreement with payment.**

If you fail to pay the assessed fine within 20 days of the date you signed for the notice and fail to request a hearing, the proposed fine will be final.


