VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Board of Chiropractic Examiners ("Board") as noticed by *Notice of Emergency Hearing – 03/03/2022 @ 8:00 AM ("Notice")*, I, Clarence Meyer hereby agree to a voluntary surrender of my New Hampshire chiropractic license (#461-A), effective upon the date that I sign this document.

By voluntarily surrendering my chiropractic license, I understand that:

1. I relinquish all rights and privileges to practice chiropractic in the State of New Hampshire as defined by RSA 316-A:1, effective the date that I sign this document.
2. I acknowledge that this *Voluntary Surrender of License* has occurred in settlement of pending misconduct allegations concerning violation of RSA 316-A:22, II(c) and/or (d). *See Notice.*
3. I admit to no violations of any State statutes, rules, or ethical provision, but recognize that the fact that my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.

4. This *Voluntary Surrender of License* shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision-making specific finding of professional misconduct.
5. This *Voluntary Surrender of License* shall become a permanent part of my file and will be maintained by the Board as a public document.
6. In the event I submit an application for licensure under RSA 316-A, I understand that the above reference pending misconduct allegations shall be addressed at a Show Cause Hearing in any future licensure application process before the Board at which I shall have the burden of proof. These misconduct allegations may then form the basis for the Board to deny any such application. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including but not limited to, those contained in RSA 332-G:8 and 9.
7. I voluntarily submit this *Voluntary Surrender of License* to the Board and state that no promises or representation have been made to me other than those terms and conditions expressly stated herein.
8. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this *Voluntary Surrender of License*.
9. I am not under the influence of any substance that would impair my judgment and am otherwise of sound mind at the time I sign this *Voluntary Surrender of License*.
