**VOLUNTARY SURRENDER OF LICENSE**

I, Mitchell Traina, an electrician licensed by the Board, hereby voluntarily surrender my license to practice pursuant to Administrative Rule Plc 205.02(e), 205.04(a), and 205.05(b) and according to the following terms and acknowledgements:

1. The voluntary surrender of my license is freely rendered;
2. By voluntarily surrendering my license, I relinquish all rights and privileges to practice in this state;
3. The voluntary surrender of my license does not constitute an admission of wrongdoing;
4. I render this voluntary surrender in recognition of, and settlement of, a disciplinary adjudicative proceeding, pursuant to RSA 310-A:1-k, III and Elec 207.07, presently pending before this Board on the following issues:
  - A. Whether or not the Licensee violated RSA 319-C:12 (II)(c) by engaging in unprofessional conduct, dishonorable conduct unworthy of, and affecting the practice of the profession when in November of 2021, he allowed four unsupervised individuals to conduct electrical work under his license at a Hannaford Supermarket in Dover, New Hampshire. *See also* Rules 405.01(a)(1) and/or (3) and/or RSA 319-C:1.
  - B. Whether or not the Licensee violated RSA 319-C:12 (II)(d) when in November of 2021, he allowed four unsupervised individuals to conduct electrical work under his license at a Hannaford Supermarket in Dover, New Hampshire. *See also* Rules 405.01(a)(1) and/or (3) and/or RSA 319-C:1.

C. Whether or not the Licensee violated RSA 319-C:12 (II)(g) by willfully or repeatedly violating provisions of RSA 319-C or Board Rules when in November of 2021, he allowed four unsupervised individuals to conduct electrical work under his license at a Hannaford Supermarket in Dover, New Hampshire. See also Rules 405.01(a)(1) and/or (3) and/or RSA 319-C:1.

5. In the event that I submit an application for licensure under RSA 319-C, I shall comply with the requirements of Elec 401.09, 402.01 and 402.03 and pay all applicable fees.
6. I understand that this voluntary surrender will be made a permanent part of my licensure file and will be maintained by the Board as a public document.
7. I hereby waive any time limitations contained within RSA 319-C:12-a, RSA 310-A, RSA 332-G, RSA 541-A, and any time-based defenses including, but not limited to, laches, in any further proceeding based on, or related to, these allegations. However, the Board shall be expressly subject to the limitation on consideration of this voluntary surrender in future disciplinary actions pursuant to RSA 319-C:12, IV.
8. I have had the opportunity to seek the advice of legal counsel prior to signing this document:
9. I am not being subjected to coercion or distress;
10. I have read and fully understand this document and the legal implications of surrendering my license;
11. I am not under the influence of any substance and am of sound mind.
