## **VOLUNTARY SURRENDER OF LICENSE**

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Advisory Board of Massage Therapists ("Board") as noticed by *Notice of Emergency Hearing* – 06/29/2023 @ 1:00 PM ("Notice"), I, Isaiah Briggs, hereby agree to a voluntary surrender of my New Hampshire massage therapist license (#8093), effective upon the date that I sign this document.

By voluntarily surrendering my massage therapist license, I understand that:

- I relinquish all rights and privileges to act as a massage therapist (License #8093) in the State of New Hampshire as defined by RSA 328-B:2, VIII., effective the date that I sign this document.
- I admit that this *Voluntary Surrender of License* has occurred in settlement of pending misconduct allegations concerning violation of RSA 328-B:3, IV. and/or N.H. Code Admin. Plc. 907.02(a)(4). *See Notice*.
- 3. I admit to no violations of any State statutes, rules, or ethical provision, but recognize that the fact that my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.

- 4. This *Voluntary Surrender of License* shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making a specific finding of professional misconduct.
- 5. This *Voluntary Surrender of License* shall become a permanent part of my file and will be maintained by the Board as a public document.
- 6. In the event I submit an application for licensure under RSA 328-B, I understand that the above reference pending misconduct allegations shall be addressed at a Show Cause Hearing in any future licensure application process before the Board at which I shall have the burden of proof. These misconduct allegations may then form the basis for the Board to deny any such application. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including but not limited to, those contained in RSA 332-G:8 and 9.
- 7. I voluntarily submit this *Voluntary Surrender of License* to the Board and state that no promises or representation have been made to me other than those terms and conditions expressly stated herein.
- 8. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this *Voluntary Surrender of License*.
- 9. I am not under the influence of any substance that would impair my judgment and am otherwise of sound mind at the time I sign this *Voluntary Surrender of License*.
