**VOLUNTARY PRELIMINARY AGREEMENT NOT TO PRACTICE**

Dumle Vite ("Respondent") is a licensed registered nurse in New Hampshire having NH multi-state license number 076547-21 which expires on 04/30/2025. The New Hampshire Board of Nursing ("Board") granted the license on 09/08/2017.

On or about 07/05/2023, the OPLC Division of Enforcement ("Division") received the above captioned complaint filed by Heidi Forrence, NHA, of Bedford Hills Center in Bedford, NH against Respondent alleging professional misconduct in violation of RSA 326-B:37, II. when he allegedly used a pen camera to record at least one coworker in a bathroom while employed at Bedford Hills Center.

Recognizing that professional misconduct allegations are pending against Respondent, the Respondent voluntarily enters into a Voluntary Preliminary Agreement Not to Practice with the Board as follows:

1. I, Dumle Vite, agree not to practice as a Registered Nurse, effective upon my signing this Voluntary Preliminary Agreement Not to Practice.
2. I admit to no violations of RSA 326-B:37, or any administrative rules, ethical provisions, or any other laws, statutes, or regulations, adopted by the Board.
3. Understanding that this *Voluntary Preliminary Agreement* and the restrictions herein shall remain until further order of the Board, I hereby specifically waive

- any statute of limitations or laches defense, which might then be available, including, but not limited to, those based on RSA 332-G:8 and 332-G:9.
4. By signing this *Voluntary Preliminary Agreement Not to Practice*, I hereby specifically waive my right to an emergency hearing pursuant to RSA 541-A:30, III; RSA 326-B:37, IV; and RSA 310-A:1-m, IV.
  5. I understand that this *Voluntary Preliminary Agreement Not to Practice* shall remain in effect until such time the ongoing investigation into this matter is completed and the Board issues a final disposition in the matter.
  6. In the event that I apply for the renewal of my license while this agreement is in effect, I voluntarily agree to waive any statutory or administrative time deadlines regarding the Board's final action on any such license renewal application. I understand that by waiving such deadlines, the Board's final action on any such license renewal application will be automatically deferred until after the disposition of this Board matter and that my license will not expire while this *Voluntary Preliminary Agreement Not to Practice* is in effect.
  7. I voluntarily enter into this *Voluntary Preliminary Agreement Not to Practice* with the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
  8. I further understand that this document shall become a permanent part of my file and will be maintained by the Board as a public document upon execution by the Board as a Board Order.



9. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with the decision to sign this *Voluntary Preliminary Agreement Not to Practice*.
10. I am of sound mind and not under the influence of any substance that would impair my judgement at the time I sign this *Voluntary Preliminary Agreement Not to Practice*.
11. I understand that my failure to comply with the terms of this *Voluntary Preliminary Agreement Not to Practice* shall constitute professional misconduct under RSA Chapter 326-B and may subject me to additional discipline.
