## VOLUNTARY SURRENDER OF LICENSE

In order to avoid the delay and expense of further proceedings before the New Hampshire Advisory Board of Massage Therapists ("Board"), I, William Blaiklock., per N.H. Code Admin. R. Plc ("Plc") 205.02(e), do hereby voluntarily surrender my New Hampshire license (#8154) to practice as a massage therapist as defined by RSA 328-B:2, VI., effective as of the date I sign this document.

By voluntarily surrendering my license, I understand that:

- I relinquish all rights and privileges to practice "massage" as a "massage
  therapist" in the State of New Hampshire as those terms are defined by RSA 328B:2, effective as of the date I sign this document.
- The Board has commenced an investigation into my practice pursuant to RSA 328-B:4, II. and Plc 204.
- 3. On August 24, 2022, the Board issued an *Order of Emergency Suspension* 08/18/22 and *Notice of Emergency Suspension Hearing* 08/24/22 @ 1:00 PM.
- 4. This license surrender has occurred in settlement of pending allegations that I inappropriately touched a customer during a massage session as detailed in the attached *Notice of Emergency Suspension Hearing* 08/24/22 @ 1:00 PM. (See Attachment 1).

- I admit to no violations of any statutes, including RSA 328-B, or any administrative rules or ethics provisions adopted by the Board.
- 6. Should I again seek licensure in the State of New Hampshire, I must meet, and shall bear the burden of proving compliance with, all standards and prerequisites then required by the Board for new applicants, including professional character requirements.
- 7. The pending allegations shall be resolved in any future licensure application I may submit in New Hampshire. I hereby specifically waive any statute of limitations or laches defense, which might then be available, including, but not limited to, those based on RSA 332-G:8 and 9. I also waive any potential issues regarding a lack of a speedy hearing or spoliation of the evidence.
- 8. Once this this document goes into effect, it will be reported as discipline and distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making specific findings of professional misconduct.
- This document shall become a permanent part of my file and will be maintained by the Board as a public document.
- 10. I voluntarily submit this surrender of license to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
- 11. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this document.

12. I am of sound mind and not under the influence of any substance that would impair my judgment at the time I sign this document.
