Hearing commenced at 10:15 am. Attorney John Brown called Inspector Sandra Hodgdon as a witness who gave testimony regarding a routine inspection that occurred on February 10, 2023. During her inspection Ms. Hodgdon found what appeared to be an unlicensed tattooing operation in a separate room in the back of the Barbershop. Ms. Hodgdon found various equipment used for tattooing services. Ms. Hodgdon viewed a scalp pigmentation certificate in Mr. Rodrigues name. Ms. Hodgdon gave testimony to the Board with the Board confirming these materials are used for tattooing.
