 - A. Update on current legislation OPLC Board Counsel, Elizabeth Eaton

1) HB 1331-Licensure from different countries – Voted to send a letter to the sponsor of the bill. a) BoDE is unclear what is needed for this legislation is asking.
b) BoDE unclear what scope of practice is allowed under a "limited license;"

c) BoDE unclear what is the definition of a "dental intern;" d) BoDE unclear on what "hospital," "other institution," or "dental infirmary" the bill is referring to. Board Counsel, Elizabeth Eaton to assist with preparing the letter to the sponsor of the bill.

2) HB 1272 – Send letter to the House Committee – BoDE has concern with public safety where certain licensees do not meet our requirements.

3) HB 1408 – BoDE concerned that reducing the number of dentists on the board would endanger the safety of the public by eliminating the varying viewpoints and realms of expertise provided by the additional dentist members.

4) HB 1676 – Send letter to the House Committee – BoDE has serious concerns that eliminating a professional board made up of individuals with experience in the profession would jeopardize the safety of the general public with respect to the practice of dentistry and dental hygiene.
