6. (a) Summary of what the rule says and of any proposed amendments:

Most of Chapter Eng 300 on licensure requirements expired 1/1/20. The Board of Professional Engineers is intending to adopt or readopt with amendment all sections of the Eng 300 rules as follows:

Adopt Eng 301.01 provides the definitions used throughout the entire section of Eng 300. The proposed adoption has not been modified from the expired rule;

Adopt Eng 302.01 describing the application process for initial licensure. The proposed adoption is being modified from the expired rule by:

- Changing the part heading "Application Requirements and Application/Examination/Licensure Fees";
- Removing the forms of payment that is acceptable;

Adopt Eng 302.02 describing the application for initial licensure. The proposed adoption is being modified from the expired rule by making minor editorial changes;

Adopt Eng 302.03 describing the fundamentals of the engineering examination. The proposed adoption has not been modified from the expired rule;

Readopt with amendment Eng 302.04 describing the application, examination, and licensure fees and is being amended to:

- Adopting application fee for licensure, licensure by reciprocity, renewal, reinstatement, and temporary certification of professional engineers; and
- Adopt of certification fees for engineering companies;

1. Comparison of the costs of the proposed rule(s) to the existing rule(s):

There is no difference in cost when comparing the proposed rules to the existing rules. Not applicable to the various rules which expired in January 2020 and are being readopted.

2. Cite the Federal mandate. Identify the impact on state funds:

No federal mandate, no impact on state funds.

3. Cost and benefits of the proposed rule(s):

- The proposed rules remove the examination for licensure as a professional engineer fee. The removal of this fee will have no impact. For the past 9 months the Office of Professional Licensure and Certification (OPLC) has required individuals to pay the exam fee directly to the exam company.
- The proposed rules change the application fee for licensure by comity or reciprocity with other states from \$250 to \$150, a decrease of \$100. There are approximately 3 applications by comity or reciprocity submitted per year which would result in a decrease in revenue of \$300.
- The biennial renewal fee for retired status is changed from \$30 to \$75 per year resulting in an indeterminable increase in revenue. There are approximately 4,148 biennial renewals, however, the OPLC does not track active status vs retired status.

A. To State general or State special funds:

There will be no direct impact on the State general fund, however after paying all costs and salaries associated with the Office, any remaining balance in the fund lapses to the general fund at the close of each biennium. There will be an indeterminable impact on revenue to the office of professional licensure and certification fund from the proposed fee changes.

B. To State citizens and political subdivisions:

There will be an indeterminable fiscal impact to State citizens who are professional engineers due to the proposed fees changes. There is no cost or benefit to political subdivisions.
