VII. Sealing of Non-Public Minutes

Motion to keep minutes of the first non-public session confidential:

However, forty-eight hours after the mailing of any order, its' respective vote shall automatically become public in accordance with RSA 329:18-a. Each member recorded his/her vote on the motion, which passed by the unanimous roll call vote of all members present. Jennifer Knox-Dassau voted remotely.
