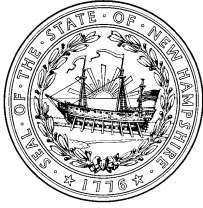

The Board has no requirements on this matter. If this pertains to a specific person they can refer to the NH Land Surveyor Association-they have a list if more info is needed.

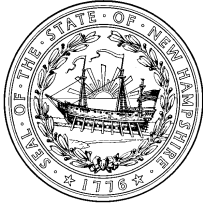
