On a motion by Linda Tatarczuch and seconded by Jonathan Eddinger with Emily Baker abstained the Board appointed Emily Baker to speak on the Boards behalf and to submit written testimony drafted by Board Counsel in conjunction with Dr. Baker.

VI. Rules/Laws/Legislation

A. Med 100, and 200 Rules

The public hearing for Med 100s commenced at 1:07pm and closed at 1:25pm with no public comment

On a motion by Nina Gardner and seconded by Richard Kardell the Board voted by roll call to approve the initial proposal of MED 200s as submitted.

B. HB655

Joan Barthold, Peter Beeson from the Medical Review Subcommittee along with and David Conway addressed the Board and voiced concerns regarding HB655 which would repeal the MRSC in its entirety. The members expressed the importance of peer review, and they are aware that they have not been working at full capacity because it has been taking a long time for new members to be appointed. They stressed that the MRSC continues to be committed to the safety of the public and continuing peer review.

VII. Board Administrator/OPLC updates

- A.** Board Member Michael Barr's resignation confirmed by G&C effective June 2023.
- B.** The Board was updated of a statutory change concerning license periods for most license types regulated by a Board, Council, or Commission within the Office of Professional Licensure and Certification OPLC. RSA 310-A:1-h was enacted in 2021. As enacted, the statute established a two-year license period for a limited number of license types identified in RSA 310-A:1-h, I. Last year, however, the legislature repealed RSA 310-A:1-h, I, effective July 1, 2022. Accordingly, the license period established by RSA 310-A:1-h is no longer restricted to certain license types. OPLC has reviewed every practice act and determined that all license types within OPLC are now subject to the two-year license period established by RSA 310-A:1-h, III with a few exceptions. The only exceptions effecting the Board of Medicine is Locum Tenens, and Physician Temporary licenses.

VIII. Public Old Business

A. PDMP – Board Representative

The Prescription Drug Monitoring Program addressed the Board at the February 1, 2023, meeting asking for a Board of Medicine representee for the PDMP Advisory Council. The Board discussed it was difficult for anyone to attend at the time the Council meets. On a motion from Richard Kardell and seconded by Jonathan Eddinger the Board voted to have Board Administrator Talia Wilson reach out to Shawn Jackson from PDMP and inquire if there is any flexibility for a BOM member to attend via Zoom.

IX. Public New Business

A. Appoint a new BOM member as IMLCC representative

The Board voted on a motion by Richard Kardell and seconded by Jonathan Eddinger to appoint Marc Bertrand as the new IMLCC representative.

B. Licensing Matrix

The Board voted on a motion by Richard Kardell and seconded by Susan Finerty to approve the created licensing matrix as amended for OPLC Licensing Division to begin to implement effective immediately.

X. Adjournment On motion by Richard Kardell, seconded by Nina Gardner, the Board voted unanimously by roll call to adjourn the public session at 4:46 p.m.
