A. Kevin Strong- 9:30am Application Show Cause Hearing

The Board voted on a motion from Marc Bertrand and seconded by Jonathan Eddinger to have Attorney Rahkiya Medley act as Hearings Officer.

The reinstatement application show cause hearing for Dr. Kevin Strong commenced at 9:27am. Hearings Officer Medley reviewed the procedural matters and swore in Dr. Strong for testimony. Dr. Strong testified that he suffered a bipolar episode after divorce and has now been stabilized and felt confident that he could perform his duties. He also stated that the states of Massachusetts and Maine have granted licensure on the premise that Dr. Strong have an employer in place with a work plan to be submitted. Dr. Strong told the Board he would be willing to submit results from a neurocognitive examination he had as well as a letter from his doctor regarding his fitness to return to work.
