- VIII. Rules Review and Other Legislative Topics
 - A. JLCAR RE: Mhp 305.02, Mhp 307, Mhp 308, and Mhp 309 Continuing Education, Social Worker, Social Work Associate, and Conditional Licensure final proposal will be reviewed at the JLCAR meeting on January 19, 2024.
 - B. Mhp 300 various 1099 discussion The Board of Mental Health Practice recently adopted rules, effective December 19, 2023, which clarify the employment status of individuals receiving supervision under an approved Candidate for Licensure: Supervision Agreement. The intent of Mhp 302.01 (k) (3), Mhp 303.02 (k), Mhp 304.02(d) (6), Mhp 305.03 (l), and Mhp 306.02 (i) has not changed with these recently adopted rules, but rather, the language has been clarified.

The Board of Mental Health Practice understands that this change in language requires many offices, supervisors, and supervisees to change their employment status from 1099 to W2 employees. To assist with the transition of employment status, the Board would like to make all current supervisors aware that they can submit waiver requests pursuant to Mhp 213, which may establish a grace period for the required change. Each supervisor need only submit one waiver request for all named supervisees
