Glee Corsetti-Hooper, President opened the meeting at 9:41 am.

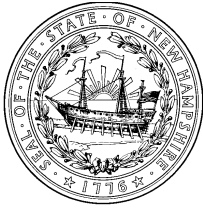
II. Approval of Minutes:

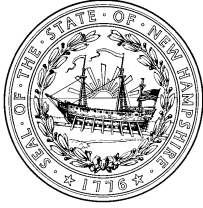

HB 262 (LSR 213): The Board takes no position on this legislation. Glee Corsetti-Hooper motioned, Bert Mathieson seconded.

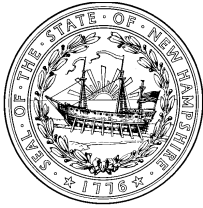

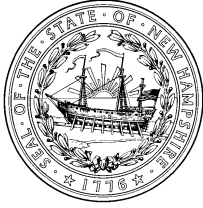
