**VOLUNTARY SURRENDER OF LICENSE**

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Board of Nursing ("Board"), I, Lindsey Holman, RN, hereby voluntarily surrender my New Hampshire RN license #058729-21 effective on the date that the Board accepts this offer of *Voluntary Surrender of License*.

By voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice as a licensee in the State of New Hampshire effective upon the Board's acceptance of this *Voluntary Surrender of License*.
2. I acknowledge that this *Voluntary Surrender of License* has occurred in settlement of pending misconduct allegations as outlined in a complaint received by the Board on June 22, 2023, reporting that while engaged as a New Hampshire Registered Nurse on June 22, 2023, I was impaired and refused to comply with drug screening.
3. I admit to no violations of any State statutes, rules, or ethical provision, however I do acknowledge if the matter went to a disciplinary hearing, there are sufficient facts to prove that I used a controlled substance without a valid prescription and having not been prescribed to me while on duty as a nurse which is a violation of the Nurse Practice Act, RSA Chapter 326-B.

4. I further acknowledge that my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.
5. This *Voluntary Surrender of License* shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making a specific finding of professional misconduct.
6. This *Voluntary Surrender of License* shall become a permanent part of my file and will be maintained by the Board as a public document.
7. In the event I submit an application for licensure under RSA 326-B, I must meet all requirements for reinstatement pursuant to RSA 326-B:23 and Nur 401.03. In addition, I agree to submit with any such application a report containing a recommendation as to my fitness to practice from my mental health provider.
8. I further understand that if at any time I apply for reinstatement of licensure, the Board shall schedule a hearing pursuant to RSA Chapter 310 and at that time, the pending misconduct allegations settled as part of this Voluntary Surrender shall be addressed in which I shall have the burden of proof to demonstrate why licensure should be reinstated. These misconduct allegations may then form the basis for the Board to deny any such application.
9. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including, but not limited to, those contained in RSA 332-G:8 and 9.
10. I voluntarily submit this *Voluntary Surrender of License* to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.

11. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this *Voluntary Surrender of License*.
12. I am of sound mind, and I am not under the influence of any substance that would impair my judgment at the time I sign this *Voluntary Surrender of License*.
