STANDING ORDER 2023-1

The Executive Director's Standing Orders in Licensing, Disciplinary, and non-Disciplinary Proceedings issued pursuant to RSA 310:10, effective July 1, 2023.

Recitals and Purpose

WHEREAS the legislature has passed, and the governor has signed New Hampshire HB 655 (2023), establishing RSA chapter "310, Office of Professional Licensure and Certification" ("Office"); and

WHEREAS this legislation applies, in part, to "Boards" as defined at RSA 310:2, II;1 and

WHEREAS this legislation requires the Office to: 1) adopt procedural rules for all licensing, disciplinary, and non-disciplinary proceedings before the Boards;² 2) employ sufficient, qualified administrative prosecutors to serve as hearing counsel in all disciplinary matters before the boards;³ and 3) employ sufficient, qualified personnel to

serve as presiding officer in all disciplinary or non-disciplinary remedial proceedings before the Boards;4 and

WHEREAS this legislation applies to licensing, disciplinary, and non-disciplinary proceedings already pending before the Boards;⁵ and

WHEREAS the Office has adopted the OPLC Chapter Plc 200 "Practice and Procedure," effective August 4, 2022; and

WHEREAS the Office has employed attorneys admitted to practice law in the State of New Hampshire to serve as administrative prosecutors/hearing counsel in all disciplinary and non-disciplinary proceedings; and

WHEREAS the Office has also contracted with the New Hampshire Department of Justice, Consumer Protection and Antitrust Bureau ("CPAB") for assistance in certain prosecutions from attorneys admitted to practice law in the State of New Hampshire; and

WHEREAS the Office has employed attorneys admitted to practice law in the State of New Hampshire to serve as counsel to all boards, councils, and commissions within the Office; and

WHEREAS the Office has employed attorneys admitted to practice law in the State of New Hampshire to serve as presiding officer in all licensing, disciplinary, and nondisciplinary proceedings; and

WHEREAS all such attorneys are qualified by reason of education, competence, and relevant experience;

NOW THEREFORE the Executive Director issues the following Standing Order with respect to the enactment of RSA 310:11 and RSA 310:10, II, III, and IV:

ORDER

- 1. Effective July 1, 2023, and applied retrospectively, the Boards shall conduct licensing, disciplinary, and non-disciplinary remedial proceedings in accordance with Chapter Plc 200 "Practice and Procedure," effective August 4, 2022, and as may be amended and/or revised from time to time thereafter; and
- 2. Effective July 1, 2023, and applied retrospectively, the Chief Administrative Prosecutor within the Office's Division of Enforcement shall assign New Hampshire licensed attorneys employed within the Division to serve as Hearings Counsel in all administrative law cases requiring prosecution. The Chief Administrative Officer shall refer cases alleging unlicensed conduct to the CPAB for consideration of criminal charges. If the CPAB declines to pursue criminal charges, the Chief Administrative

Officer shall assign a New Hampshire licensed attorney within the Division to pursue administrative action in such matters.

- 3. Effective July 1, 2023, and applied retrospectively, New Hampshire licensed attorneys employed by the Office as Hearings Examiners shall, in the first instance, serve as Presiding Officer in all disciplinary and non-disciplinary proceedings before the Boards. As necessary, the Executive Director may designate other New Hampshire licensed attorneys employed by the Office to serve as Presiding Officer in disciplinary and non-disciplinary proceedings before the Boards.
- 4. Effective July 1, 2023, and applied retrospectively, any policy autonomous Board may appoint the Office's designated Hearings Examiners to serve as Presiding Officer in all licensing proceedings before them.
- 5. Effective July 1, 2023, and applied retrospectively, the Office's designated Hearings Examiners shall serve as Presiding Officer in all licensing proceedings conducted under the regulatory authority of the Office and its advisory boards.⁶
