 - A. LSR 1001 An Act Relative to Optometrists.

Curtis Barry advised that this bill was drafted at the request of NHOA to address an issue experience by optometrists during the pandemic. Optometrists wanted to assist by administering vaccines by injection, but RSA 327:1, III(h) prevented optometrists from doing it. The LSR has been published as SB 200.
