**II. Licensing/Applications**

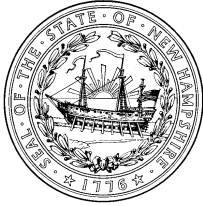

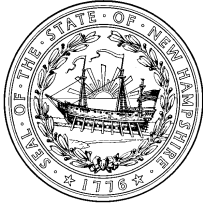

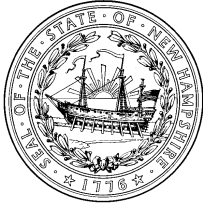
