- 1. "25 Day" Rulemaking request The Board submitted a rule change notification regarding the "25 day" referral related to 2023 legislation HB 188. Legislation passed, the Rulechange notification will be withdrawn.

 - 1. LSR Update Tabled to the March 19, 2024 meeting

HB 1112 - relative to establishing a continuing education requirement regarding human trafficking for individuals licensed by the office of professional licensure and certification - Opposed.

HB 1272 - relative to occupational license reciprocity.

HB 1676 - establishing a sunset commission to evaluate various occupational boards and commissions, and sunsetting various boards and commissions.

HB 1408 - relative to the merger of and reorganization of various occupational boards.

HB 1095 - relative to the official pronunciation of "New Hampshire" and "Concord." The Board requested guidance as far as veterinarian certifications in relation to HB 1095.
