I. Call To Order

Jennifer Carrier, Chair, called the meeting to order at 8:39 am.

II. Approval of Public Minutes

Motion:

 - A. Staffing change

IV. New Business

Liz Eaton, Board Counsel, discussed the topic of animal PTs, noting that the Vet Board did not want anything to do with the oversight of this. The Board noted that it made sense for any rules regarding this to come from the PTGB as they

would be the subject matter experts. They also acknowledged that any complaints regarding animal PTs should come to their Board for review, and not go to the Vet Board. The Board asked that Tina Kelley, OPLC Rules, be available at the next meeting, if possible, to begin writing rules that would address animal PTs.

C. HB188

Robert Worden brought up HB188, a bill that would repeal the 25 day referral requirement.

B. Legislative Update

Liz Eaton outlined HB507, which proposed sweeping changes to unlicensed practice, and would allow anyone to practice any profession as long as they stated they were not licensed.

Motion:

Have Board Counsel provide written testimony, on behalf of the Board, in opposition to HB507.

Motion moved by Jennifer Carrier and motion seconded by Lea Bruch. Motion passed unanimously.

Liz Eaton also discussed HB655, which came about as a result of a Committee stufy on OPLC; she specifically referenced potential chnages to reciprocity.

VII. Non-Public Session
