

**Effective April 23, 2025, Plc 1004 reads as follows:****PART Plc 1004 EXAMINATION FEES FOR LICENSING-RELATED EXAMS ADMINISTERED UNDER CONTRACT**

Statutory Authority: RSA 310:6, I

Plc 1004.01 Purpose. The purpose of this part is to establish the fees for examinations that will be charged by the third party testing organization(s) with whom the office of professional licensure and certification (OPLC) has contracted to administer the exam(s).

Plc 1004.02 Applicability. The fees in this part shall apply to any applicant who is required by applicable law to pass an examination that is administered by a third party testing organization with whom the OPLC has contracted to administer the exam to be eligible for licensure.

Plc 1004.03 Examination Fees for Professions Regulated by the Board of Barbering, Cosmetology, and Esthetics. The examination fees for the professions regulated by the board of barbering, cosmetology, and esthetics under RSA 313-A shall be as follows:

(a) The fees for barber examinations, equivalent to barber I examinations, shall be:

- (1) For the written exam, \$88.00; and
- (2) For the practical exam, \$99.00.

(b) The fees for master barber examinations, equivalent to barber styling examinations, shall be:

- (1) For the written exam, \$88.00; and
- (2) For the practical exam, \$99.00.

(c) The fees for cosmetologist, esthetician, or manicurist examinations shall be:

- (1) For the written exam, \$88.00; and
- (2) For the practical exam, \$99.00.

(d) The fees for microblading examinations, equivalent to permanent cosmetics or micropigmentation examinations, shall be:

- (1) For the written exam, \$18.00; and
- (2) For the practical exam, \$20.00.

Plc 1004.04 Jurisprudence Examination Fee for the Profession Regulated by the Board of Chiropractic Examiners. The fee for the jurisprudence examination for chiropractors as regulated by the board of chiropractic examiners under RSA 316-A shall be \$69.00.

Plc 1004.05 Jurisprudence Examination Fee for Dentists. The fee for the jurisprudence examination for dentists as regulated by the board of dental examiners under RSA 317-A shall be \$69.00.

Plc 1004.06 Examination Fees for the Professions Regulated by the Electricians' Board. The examination fees for the professions regulated by electricians' board under RSA 319-C shall be as follows:

- (a) For the journeyman electrician examination, \$90.00;
- (b) For the master electrician examination, \$90.00; and

(c) For the electrician re-licensing examination, \$70.00.

Plc 1004.07 Jurisprudence Examination Fees for Foresters. The fee for the jurisprudence examination for foresters as regulated by the board of licensing for foresters under RSA 310-A:98-117 shall be \$40.00.

Plc 1004.08 Jurisprudence Examination Fees for Funeral Directors. The fee for the jurisprudence examination for funeral directors as regulated by the board of registration of funeral directors and embalmers under RSA 325 shall be \$40.00.

Plc 1004.09 Jurisprudence Examination Fees for Land Surveyors. The fee for the jurisprudence examination for land surveyors as regulated by the board of licensure for land surveyors under RSA 310-A:53-74 shall be \$40.00.

Plc 1004.10 Examination Fees for Professions Regulated by the Mechanical Licensing Board. The examination fees for professions regulated by the mechanical licensing board under RSA 153:27-38 shall be as follows:

- (a) First year plumbing apprentice bypass, \$90.00;
- (b) Journeyman plumber examination, \$90.00; and
- (c) Master plumber examination, \$90.00.

Plc 1004.11 Jurisprudence Examination Fees for Midwifery. The fee for the jurisprudence examination for midwives as regulated by the midwifery council under RSA 326-D shall be \$40.00.

Plc 1004.12 Examination Fees for Professions Regulated by the Board of Natural Scientists. The examination fees for the professions regulated by the board of natural scientists under RSA 310-A:75-96 shall be as follows:

- (a) For the soil scientist theory exam, \$69.00; and
- (b) For the wetlands scientist theory exam, \$69.00.

Plc 1004.13 Jurisprudence Examination Fees for the Profession Regulated by the Naturopathic Board of Examiners. The fee for the jurisprudence exam for naturopaths as regulated by the naturopathic board of examiners under RSA 328-E shall be \$40.00.

Plc 1004.14 Jurisprudence Examination Fees for the Profession Regulated by the Board of Registration in Optometry. The fee for the jurisprudence examination for the profession regulated by the board of registration in optometry under RSA 327 shall be \$69.00.

Plc 1004.15 Jurisprudence Examination Fees for the Profession Regulated by the Board of Professional Engineers. The fee for the jurisprudence examination for professional engineers as regulated by the board of professional engineers under RSA 310-A:2-27 shall be \$69.00.

Plc 1004.16 Jurisprudence Examination Fees for the Professions Regulated by the Board of Psychologists. The fee for the jurisprudence exam for psychologists as regulated by the board of psychologists under RSA 329-B shall be \$40.00.

Plc 1004.17 Examination Fees for the Professions Regulated by the Real Estate Appraisers Board. The examination fees for the professions regulated by the real estate appraisers board under RSA 310-B shall be as follows:

- (a) For a licensed residential appraiser, \$90.00;
- (b) For a certified residential appraiser, \$90.00; and
- (c) For a certified general appraiser, \$90.00

Plc 1004.18 Examination Fees for the Professions Regulated by the Real Estate Commission. The examination fees for the professions regulated by the real estate commission under RSA 331-A shall be as follows:

- (a) For real estate brokers, \$36.00 for the national portion and \$34.00 for the state portion; and
- (b) For real estate salespersons, \$34.00 for the national portion and \$32.00 for the state portion.

Plc 1004.19 Jurisprudence Examination Fees for Septic System Evaluators. The fee for the jurisprudence exam for the profession regulated by the board of septic system evaluators under RSA 310-A:202-221 shall be \$40.00.

Plc 1004.20 Jurisprudence Examination Fees for the Profession Regulated by the Board of Veterinary Medicine. The fee for the jurisprudence exam for the profession regulated by the board of veterinary medicine under RSA 332-B shall be \$69.00.
