Qualified vendors include physicians or physician assistants who are licensed, or previously licensed, by the Board of Medicine with no restrictions to practice in the State of New Hampshire.
2.	Subsection 1.5. Is sending my CV or resume adequate for answering the RFA questions?	No. Please see the "*" note after Paragraph 1.5.3.
3.	Paragraph 1.5.2 Would OPLC accept a redacted final report that is not mine in totality, but in which my assessments were included?	A redacted final report that is not yours in totality, but in which your assessments were included may be acceptable so long as the portions that are yours are clearly identified.
4.	Subsection 2.3 How do I submit my application?	See Subsection 2.3 for specific instructions on how to e-mail your application to OPLC for consideration.
