FINAL DECISION AND ORDER

On March 8, 2012, the New Hampshire Board of Medicine issued a Notice of Hearing to Show Cause to Corey J. Meyers, M.D. The Notice of Hearing was issued after the New Hampshire Board of Medicine received information that Dr. Meyers had been disciplined by the State of New York Department of Health, State Board for Professional Medical Conduct. The Notice of Hearing provided Dr. Meyers with proper notice of the adjudicatory hearing which took place on July 11, 2012 at 1:00pm. Dr. Meyers was ordered to appear for the purpose of showing cause why reciprocal disciplinary sanctions should not be imposed against his New Hampshire license pursuant to RSA 329:17-c.

On July 11, 2012, a Show Cause hearing was held at the Board's office. Board members¹ present at the hearing were:

The prosecution was represented by Hearing Counsel Assistant Attorney General Sarah Blodgett of the Administrative Prosecutions Unit (“APU”) of the Office of the Attorney General. Dr. Meyers appeared *pro se*.

The following exhibits were introduced into evidence and accepted into the record:

Based upon the evidence presented to the Board, including the Exhibits presented at the hearing and the testimony of Dr. Meyers, the Board has determined that reciprocal disciplinary sanctions are not appropriate in this matter. The Board has serious concerns about Respondent’s competency to practice medicine and therefore is indefinitely suspending his license pending a full evaluation of his competency to practice clinical medicine.

IT IS ORDERED that the Respondent’s New Hampshire Medical License is INDEFINITELY SUSPENDED.

IT IS FURTHER ORDERED that Respondent shall at his own expense, within twelve months of the date of this Order, meaningfully participate in an assessment of his medical skills through CPEP -- Center for Personalized Education for Physicians -- that will provide an assessment of Respondent’s medical skills which will include, but not be limited to Respondent’s ability to appropriately diagnose, and to provide follow-up patient care, to adequately document all consultation included in the evaluation of the patient’s condition as well as the rationale for treatment decisions. The assessment shall also include an evaluation of appropriate interactions with patients and medical

professionals involved in patient care. Respondent shall follow all recommendations made by the assessment.

IT IS FURTHER ORDERED that within thirty (30) days of completion of the medical skills assessment Respondent shall provide the Board with a copy of any and all reports, letters, or assessments and recommendations generated as a result of the assessment.

IT IS FURTHER ORDERED that Respondent shall sign any and all releases that may be necessary to insure that the Board can speak with representatives of the assessment program to address any questions related to Respondent's practice that the Board might have as a result of the information generated by the assessment. Such releases should also enable the Board to receive any reports and information related to the completion of any follow up recommendations made by the assessment. Respondent shall provide the Board with documentation of his progress and completion of any follow up recommendations made by the medical skills assessment.

IT IS FURTHER ORDERED that Respondent shall sign any and all releases for CPEP to obtain any information from the Board necessary to perform its evaluation.

IT IS FURTHER ORDERED that all actions recommended by the CPEP assessment shall be completed within 24 months of the date of this Order. Respondent's failure to do so shall require him to come before the Board to show cause why his license should be reinstated.

IT IS FURTHER ORDERED that whether to lift the suspension of Respondent's license will be at the sole discretion of the Board.

IT IS FURTHER ORDERED that Respondent shall bear all the costs of treatment, evaluation, and reporting required by this Order, but he shall be permitted to share such costs with third parties.

IT IS FURTHER ORDERED that this Order shall become a permanent part of Respondent's file which is maintained by the Board as a public document.

IT IS FURTHER ORDERED that this Order shall take effect as an Order of the Board on the date an authorized representative of the Board signs it.
