## PRELIMINARY AGREEMENT NOT TO PRACTICE

The New Hampshire Board of Medicine ("Board") granted Eric L. Knight ("Respondent"), a State of New Hampshire license to practice medicine on April 4, 2001.

Respondent enters into a Preliminary Agreement Not to Practice with the Board as follows:

- 1. Recognizing that professional misconduct allegations are now pending against me before the Board, I, Eric L. Knight, M.D., hereby voluntarily agree not to practice medicine, which includes, but is not limited to, writing prescriptions, examining/seeing patients, diagnosing patients, and treating patients, until further order of the Board.
- 2. I admit to no violations of any statutes, including RSA 329:17, VI and RSA 632-A:2, I, or any administrative rules or ethics provisions adopted by the Board.
- 3. Understanding that these restrictions shall remain until further order of the Board, I hereby specifically waive any statute of limitations or laches defense, which might then be available, including, but not limited to, those based on RSA 332-G:8 and 9. I also waive any potential issues regarding a lack of a speedy hearing or spoliation of the evidence.
- 4. I understand that this document will have the effect of indefinitely staying the Board's scheduled hearing, and final decision, on my pending license renewal application and

that while this document is in effect my license will not expire. I hereby waive any statutory or administrative deadlines regarding a final decision on my pending license renewal application.

5. I further understand that this document shall become a permanent part of my file, and will be maintained by the Board as a public document.

6. I voluntarily enter into this agreement with the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.

7. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this document.

8. I am of sound mind and not under the influence of any substance that would impair my judgment at the time I sign this document.
