## PRELIMINARY AGREEMENT NOT TO PRACTICE

The New Hampshire Board of Medicine ("Board") granted Hugh V. MacDonald, M.D. ("Respondent"), a State of New Hampshire license to practice medicine on December 6, 2006. Respondent holds license number 13349.

Respondent enters into a *Preliminary Agreement Not to Practice* ("Preliminary Agreement") with the Board as follows:

- 1. Recognizing that professional misconduct allegations are now pending against me before the Board, I, Hugh V. MacDonald, M.D., hereby voluntarily agree not to practice medicine, which includes, but is not limited to, writing prescriptions, examining/seeing patients, diagnosing patients, and treating patients, until further order of the Board.
- 2. I understand that the hearing that had been scheduled on the Emergency Order of License Suspension will be canceled by the Presiding Officer upon the Board's approval of this Preliminary Agreement.
- 3. I admit to no violations of any statutes, including RSA 329:17, VI and RSA 632-A:2, I, or any administrative rules or ethics provisions adopted by the Board.
- 4. Understanding that this Preliminary Agreement and the restrictions herein shall remain until further order of the Board, I hereby specifically waive any statute of limitations or laches defense, which might then be available, including, but not limited to, those based on RSA

332-G:8 and 9. I also waive any potential issues regarding a lack of a speedy hearing or

spoliation of the evidence.

5. In the event that I apply for the renewal of my license while this agreement is in

effect, I voluntarily agree to waive any statutory or administrative time deadlines regarding the

Board's final action on such license renewal application. I understand that by waiving such

deadlines, the Board's final action on any such license renewal application will be automatically

deferred until after the disposition of this Board matter and that my license will not expire while

this Preliminary Agreement is in effect.

6. I voluntarily enter into this Preliminary Agreement with the Board and state that

no promises or representations have been made to me other than those terms and conditions

expressly stated herein.

7. I have had the opportunity to seek and obtain the advice of an attorney of my

choosing in connection with my decision to sign this Preliminary Agreement.

8. I am of sound mind and not under the influence of any substance that would

impair my judgment at the time I sign this Preliminary Agreement.
