VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Board of Medicine ("Board"), I, Nancy A. Kressin, hereby agree to a voluntary surrender of my New Hampshire license #11759, effective upon the date that I sign this document.

By voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice medicine in the State of New Hampshire, effective as of the date that I sign this document.
2. I admit that this *Voluntary Surrender of License* has occurred in settlement of pending misconduct allegations that I:
 - a. reported to work at the Lakes Region General Hospital in Laconia on or about September 15, 2017 and provided anesthesia services to a patient or patients while under the influence of and/or impaired by an intoxicating substance or substances;
 - b. failed to submit complete and truthful information in a written response to the allegations, and/or failed to cooperate in the Board's investigation by refusing to be interviewed.

3. I deny, and admit to no violations of any State statutes, rules, or ethical provisions, but recognize that the fact of my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.
4. I understand that this *Voluntary Surrender of License* shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making specific finding of professional misconduct.
5. I understand that this *Voluntary Surrender of License* shall become a permanent part of my file, and will be maintained by the Board as a public document.
6. I have no current intention to again seek licensure by this Board, or by any other State's Board of Medicine, and I understand that, in the event that I fail to comply with this agreement and submit a licensure application to this Board, such licensure application may be denied solely on the basis of this *Voluntary Surrender of License*. In the event that the Board does not deny such an application on that basis, I understand that the above referenced pending misconduct allegations shall be addressed at a Show Cause Hearing in any future licensure application process before the Board at which I shall have the burden of proof, and that these misconduct allegations may form the basis for the Board to deny any such application. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including, but not limited to, those contained in RSA 332-G:8 and 9.

My decision to sign this *Voluntary Surrender of License* has not been the result of any coercion, duress, or improper influence by anyone or by the Board.
9. I am not under the influence of any substance that would impair my judgment at the time I sign this *Voluntary Surrender of License*.
