VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending against me before the Board of Natural Scientists ("Board"), I, Nathan Fogg, hereby agree to a voluntary surrender of my New Hampshire license #00208, effective upon signing.

By voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice the natural sciences in the State of New Hampshire, effective upon signing.
2. I admit that this *Voluntary Surrender of License* has occurred in settlement of pending misconduct allegations that I committed the crime of theft by deception, a class A felony, and official oppression, a class A misdemeanor.
3. I admit to no violations of any State statutes, rules, or ethical provisions, but recognize that the fact of my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.
4. I understand that this *Voluntary Surrender of License* shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making specific finding of professional misconduct.


5. I understand that this *Voluntary Surrender of License* shall become a permanent part of my file, and will be maintained by the Board as a public document.
6. I understand that should I again seek licensure by this Board, I must meet, and shall bear the burden of proving compliance with, all of the standards and prerequisites then required by the Board for new applicants, including all professional character requirements.
7. I further understand that the pending misconduct allegations shall be addressed in any future licensure application that I may submit to the Board and that such allegations may form the basis for the Board to deny any such application. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including, but not limited to, those contained in RSA 332-G:8 and 9.
8. I voluntarily submit this *Voluntary Surrender of License* to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
9. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this *Voluntary Surrender of License*.
10. I am not under the influence of any drugs or alcohol at the time I sign this *Voluntary Surrender of License*.


