- I, Marcelo Araujo, an electrician licensed by the Board, hereby voluntarily surrender my license to practice pursuant to Administrative Rule Plc 205.02(e), 205.04(a), and 205.05(b) and according to the following terms and acknowledgements:
 - The voluntary surrender of my license is freely rendered;
 - By voluntarily surrendering my license, I relinquish all rights and privileges to practice in this state;
 - 3. The voluntary surrender of my license does not constitute an admission of wrongdoing;
 - 4. I render this voluntary surrender in recognition of, and settlement of, a disciplinary adjudicative proceeding, pursuant to RSA 310-A:1-k, III and Elec 207.07, presently pending before this Board on the following issues (the underlying allegations of which I still dispute):
 - A. Whether or not the Licensee violated RSA 319-C:12 (II)(c) by engaging in unprofessional conduct, dishonorable conduct unworthy of, and affecting the practice of the profession when in October of 2021, while still subject to the terms of a settlement agreement for a disciplinary matter, he provided to Brian Haskell unlicensed individuals for performing electrical installations, specifically Bruno Monteiro and/or Eduardo Silva, at a Home Depot in Salem New Hampshire. *See also* Rules 405.01(a)(1) and/or (3) and Rule 405.03(h) and/or RSA 319-C:1.
 - B. Whether or not the Licensee violated RSA 319-C:12 (II)(d) when in October of 2021, while still subject to the terms of a settlement agreement for a disciplinary matter, he

provided to Brian Haskell unlicensed individuals for performing electrical installations, specifically Bruno Monteiro and/or Eduardo Silva, at a Home Depot in Salem New Hampshire. *See* Rules 405.01(a)(1) and/or (3) and Rule 405.03(h) and/or RSA 319-C:1.

- C. Whether or not the Licensee violated RSA 319-C:12 (II)(g) by willfully or repeatedly violating provisions of RSA 319-C or Board Rules when in October of 2021, while still subject to the terms of a settlement agreement for a disciplinary matter, he provided to Brian Haskell unlicensed individuals for performing electrical installations, specifically Bruno Monteiro and/or Eduardo Silva, at a Home Depot in Salem New Hampshire. See Rules 405.01(a)(1) and/or (3) and/or Rule 405.03(h) and/or RSA 319-C:1.
- D. Upon a finding of misconduct pursuant to RSA 319-C:12(II), whether and to what extent Licensee should be subjected to one or more of the disciplinary sanctions authorized by RSA 319-C:12(III).
- E. Upon a finding of misconduct pursuant to RSA 319-C:12(II), whether, pursuant to Rule 405.03(h), the misconduct occurred during a period of deferred time such that the deferred time shall be imposed, in addition to any disciplinary action taken by the Board on the misconduct that occurred during that period.
- I will not submit an application for licensure to the New Hampshire Board of Electricians within 2 years of the date of this voluntary surrender.
- In the event that I submit an application for licensure under RSA 319-C, I shall comply with
 the requirements of any applicable laws and regulations, disclose this voluntary surrender to
 the Board and pay all applicable fees.
- 7. I understand that this voluntary surrender will be made a permanent part of my licensure file

and will be maintained by the Board as a public document.

- The Board shall be expressly subject to the limitation on consideration of this voluntary surrender in future disciplinary actions pursuant to RSA 319-C:12, IV.
- 9. I have had the opportunity to seek the advice of legal counsel prior to signing this document;
- 10. I am not being subjected to coercion or distress;
- 11. I have read and fully understand this document and the legal implications of surrendering my license;
- 12. I am not under the influence of any substance and am of sound mind.
