VOLUNTARY SURRENDER OF LICENSE

Code Admin. R Med 412.03.

By voluntarily surrendering my medical license, I understand that:

- I relinquish all rights and privileges to practice medicine in the State of New Hampshire, effective the date that I sign this document.
- The Board had commenced an investigation pursuant to RSA 329:18, and a Notice of Hearing was issued by the Board on 07/19/2022. See Attached.
- I admit that this Voluntary Surrender of License has occurred in settlement of the pending misconduct allegations outlined in the Notice of Hearing referenced in paragraph 2 of this Voluntary Surrender of License.
- 4. I admit to no violations of any State statutes, rules, or ethical provision, but recognize that the fact that my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.

I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including but not limited to, those contained in RSA 332-G:8 and 9. I further waive any issues of a speedy hearing or spoliation of evidence.

 and conditions expressly stated herein.
