VOLUNTARY PRELIMINARY AGREEMENT NOT TO PRACTICE

The New Hampshire Board of Nursing (“Board”) first granted Robert Allore (“Mr. Allore or Respondent”) a license to practice as a Registered Nurse (“RN”) on November 24, 1997, and he was issued license number 044347-21.

On October 11, 2022, the OPLC Division of Enforcement was notified by Adult Protective Services (“APS”) via email a complaint had been received by APS relative to a possible sexual assault involving the Respondent and a patient.

On October 12, 2022, the OPLC Division of Enforcement received a formal written complaint submitted by a representative of the Rockingham County Visiting Nurse Association and Hospice notifying our division the Respondent failed to maintain professional boundaries with a patient and requested or offered sexual favors or used language or engaged in behaviors suggestive of same; and, or, engaged in sexual conduct with the patient in the course of providing home health services.

OPLC Division of Enforcement Program Specialist Lynne Theuner began investigating this matter and learned that the Raymond, NH Police Department is investigating this matter. On October 18, 2022, Program Specialist Theuner spoke with a detective at the Raymond, NH Police Department and was informed the department will be pursuing this matter. It was also

discovered the Respondent is in the process of seeking employment at another location at this time.

The allegations listed in the complaint may rise to the level of misconduct pursuant to NH RSA 326-B and may be grounds for emergency suspension of the Respondent's license pursuant to NH RSA 326-B: 37, IV.

In lieu of an emergency suspension of licensure, Mr. Allore enters into a *Voluntary Preliminary Agreement Not to Practice* with the Board as follows:

1. I, Robert Allore, voluntarily agree not to practice as a RN in the State of New Hampshire, effective upon my signing this *Voluntary Preliminary Agreement Not to Practice*.
2. I admit to no violations of NH RSA 326-B or any administrative rules, ethical provisions, or any other laws, statutes, or regulations, adopted by the Board.
3. Understanding that this *Voluntary Preliminary Agreement* and the restrictions herein shall remain until further order of the Board. I hereby specifically waive any statute of limitations, or laches defense, which might be then available, including but not limited to, those based on RSA 332-G: 8 and RSA 332-G: 9.
4. I understand that this *Voluntary Preliminary Agreement Not to Practice* shall remain in place until such time the ongoing investigation into this matter is completed and the adjudicatory process has been completed.
5. In the event that I apply for a renewal of my license while this agreement is in effect, I voluntarily agree to waive any statutory or administrative time deadlines regarding the Board's final action on any such license renewal application. I understand that by waiving such deadlines, the Board's final action on any such license renewal

application will be automatically deferred until after the disposition of this Board matter and that my license will not expire while this Preliminary Agreement is in effect.

6. I enter into this *Voluntary* Preliminary Agreement Not to Practice with the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
7. I further understand that this document shall become a permanent part of my file and will be maintained by the Board as a public document upon execution by the Board as a Board Order.
8. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this Preliminary Agreement.
9. I am of sound mind and not under the influence of any substance that would impair my judgement at the time I sign this *Voluntary* Preliminary Agreement Not to Practice.
10. I understand that my failure to comply with the terms of this *Voluntary* Preliminary Agreement Not to Practice shall constitute unprofessional conduct under RSA 326-B: 37 and may subject me to discipline under RSA 326-B: 37.
