VOLUNTARY PRELIMINARY AGREEMENT NOT TO PRACTICE

The New Hampshire Board of Nursing ("Board") first granted Kathleen Dorr ("Ms. Dorr or Respondent") a license to practice as a Registered Nurse ("RN") on January 21, 2021. Ms. Dorr was issued license number 084177-21.

On or about November 6, 7, and 8, 2022, the Office of Professional Licensure and Certification received three (3) separate complaints alleging violations of RSA 326-B and administrative rules governing the practice of nursing in the State of New Hampshire.

Recognizing the complaints filed against Ms. Dorr allege professional misconduct, Ms. Dorr enters into a *Voluntary* Preliminary Agreement Not to Practice with the Board as follows:

- I, Kathleen Dorr, voluntarily agree not to practice as a RN effective upon my signing this Voluntary Preliminary Agreement Not to Practice.
- I admit to no violations of NH RSA 326-B or any administrative rules, ethical provisions, or any other laws, statutes, or regulations, adopted by the Board.
- 3. Understanding that this Voluntary Preliminary Agreement and the restrictions herein shall remain until further order of the Board. I hereby specifically waive any statute of limitations, or laches defense, which might be then available, including but not limited to, those based on RSA 332-G: 8 and RSA 332-G: 9.

- 4. I understand that this Voluntary Preliminary Agreement Not to Practice shall remain in place until such time the ongoing investigation into this matter is completed and the adjudicatory process has been completed.
- I understand I will cooperate and meaningfully participate with the New Hampshire Professionals Health Program ("NHPHP"), and fulfill all requirements and recommendations set forth by the NHPHP.
- 6. I understand before returning to my duties as a RN, I will have to appear before the Board at a hearing to demonstrate satisfaction of requirements set forth by the NHPHP along with a recommendation by the NHPHP.
- 7. In the event that I apply for a renewal of my license while this agreement is in effect, I voluntarily agree to waive any statutory or administrative time deadlines regarding the Board's final action on any such license renewal application. I understand that by waiving such deadlines, the Board's final action on any such license renewal application will be automatically deferred until after the disposition of this Board matter and that my license will not expire while this Preliminary Agreement is in effect.
- 8. I enter into this Voluntary Preliminary Agreement Not to Practice with the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
- I further understand that this document shall become a permanent part of my file and will be maintained by the Board as a public document upon execution by the Board as a Board Order.
