VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Board of Nursing ("Board"), I, Elizabeth Frost, RN, hereby voluntarily surrender my New Hampshire RN license (#084140-21) effective on the date that the Board accepts this offer of *Voluntary Surrender of License*.

By voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice as a Registered Nurse in the State of New Hampshire effective upon the Board's acceptance of this *Voluntary Surrender of License*.
2. I acknowledge that this *Voluntary Surrender of License* has occurred in settlement of pending misconduct as outlined in a Notice of Hearing dated January 27, 2022 and a Notice of Hearing dated October 28, 2022. I acknowledge the truth of the material facts pertaining to those allegations.
3. I further acknowledge that my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.
4. This *Voluntary Surrender of License* shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making a specific finding of professional misconduct.

5. This *Voluntary Surrender of License* shall become a permanent part of my file and will be maintained by the Board as a public document.
6. In the event I submit an application for licensure under RSA 326-B, I must meet all requirements for reinstatement pursuant to RSA 326-B:23 and Nur 401.03. In addition, I agree to submit with any such application a report containing a recommendation as to my fitness to practice from my mental health provider.
7. I further understand that the pending misconduct allegations shall be addressed at a Show Cause Hearing in any future licensure application before the Board at which I shall have the burden of proof. These misconduct allegations may then form the basis for the Board to deny any such application. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including, but not limited to, those contained in RSA 332-G:8 and 9.
8. I voluntarily submit this *Voluntary Surrender of License* to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
9. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this *Voluntary Surrender of License*.
10. I am of sound mind and I am not under the influence of any substance that would impair my judgment at the time I sign this *Voluntary Surrender of License*.
