PRELIMINARY AGREEMENT NOT TO PRACTICE MODERATE SEDATION

The New Hampshire Board of Dental Examiners ("Board") first granted Dr. Sameer Dogra ("Dr. Dogra") a restricted permit to perform Moderate Sedation on or about August 5, 2014. On or about June 25, 2021, Dr. James Haas and Dr. Chandler Jones performed a comprehensive evaluation of Dr. Dogra and submitted a report to the Board with a recommendation Dr. Dogra fail the evaluation.

Dr. Dogra agrees to enter into a Preliminary Agreement Not to Practice Moderate Sedation in his dental practice until the Board issues formal approval as follows:

1. I, Dr. Sameer Dogra, voluntarily agree to immediately cease the use of Moderate Sedation in my practice upon my signing this Preliminary Agreement Not to Practice Moderate Sedation.
2. I admit to no violations of NH RSA 317-A or any administrative rules, ethical provisions, or any other laws, statutes, or regulations, adopted by the Board.

3. Understanding that this Preliminary Agreement and the restrictions herein shall remain until further order of the Board, I hereby specifically waive any statute of limitations, or laches defense, which might be then available, including but not limited to, those based on RSA 332-G: 8 and RSA 332-G: 9.
4. I understand that I may request a hearing on this Preliminary Agreement at any time and a hearing on this matter will be scheduled within thirty (30) days of the filing or the next available hearing date.
5. I voluntarily enter into this Preliminary Agreement with the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
6. I further understand that this document shall become a permanent part of my file, and will be maintained by the Board as a public document.
7. I have had the opportunity to seek and obtain the advice of an attorney of my choosing in connection with my decision to sign this Preliminary Agreement.
8. I am of sound mind and not under the influence of any substance that would impair my judgement at the time I sign this Preliminary Agreement.
9. I understand that my failure to comply with the terms of this Preliminary Agreement Not to Practice Moderate Sedation shall constitute
